- Container:** 17 oz. | **Active Ingredient:** 0.1% 2-Phenethyl Propionate
- Great substitute for pyrethrum products • Quick knockdown & kill
 - Great for flushing insects • Will not contaminate baits • Non-staining • Unscented
 - Interior & Exterior use

 - Interior & Exterior use • Labeled for Bedbugs (On Mattress Applications)

EcoPCO WP•X Wettable Powder Insecticide

- Quick knockdown & kill • Microencapsulation Effect: Long residual protection

- EPA “minimum risk” pesticides (FIFRA 25b products) • Exempt from U.S. EPA registration
- USDA National Organic Program (NOP) compliant • Low impact on human health
- Lowest toxicity to non-targeted organisms (birds, fish, animals) • Low use rates
- Lowest risk of groundwater contamination • Low pest resistance potential
- Compatibility with Integrated Pest Management (IPM) practices

EcoEXEMPT KO Unscented Contact Aerosol Insecticide

- Container:** 14 oz. | **Active Ingredient:** 5.0% 2-Phenethyl Propionate, 0.5% Eugenol
- Quick knockdown & kill • Strong flushing action • Soft botanical scent
 - Interior & Exterior use • Labeled for Bedbugs

EcoEXEMPT JET Wasp & Hornet Jet Aerosol Insecticide

- Container:** 14 oz. | **Active Ingredient:** 2.0% 2-Phenethyl Propionate, 3.0% Rosemary Oil
- Immediate knockdown & kill • Reaches up to 18 feet • Non-staining • Unscented
 - High dielectric for safe use around electrical equipment • No aquatic toxicity

EcoEXEMPT D Dust Insecticide

- Container:** 10 oz. & 5 lb. | **Active Ingredient:** 4.5% 2-Phenethyl Propionate, 2.0% Soybean Oil, 1.75% Eugenol
- Quick knockdown & kill • Residual protection • Water-resistant and non-clumping
 - Non-staining and non-corrosive • Interior & Exterior use • Soft botanical scent

EcoEXEMPT G Granular Insecticide

- Container:** 22 lb. | **Active Ingredient:** 2.90% Eugenol, 0.6% Thyme Oil
- Quick control • Residual protection • No watering requirements
 - Low aquatic toxicity • Botanical scent

EcoEXEMPT IC-2 Residual Insecticide Concentrate

- Container:** 1 gal | **Active Ingredient:** 10.0% Rosemary Oil, 2% Peppermint Oil
- Quick knockdown & kill • Residual protection • Non-staining • No aquatic toxicity
 - Extremely versatile: for conventional, misting, and fogging equipment
 - Interior & exterior use • Soft botanical fragrance

EcoADJUVANT Emulsifier/Spreader

- Container:** 1 pint | **Active Ingredient:** NA
- Improves effectiveness and emulsification of EcoEXEMPT IC-2 and most other pesticides
 - Easy to use tip & pour container

EcoEXEMPT MC / EcoEMULSIFIER Misting Concentrate Insecticide

- Container:** 1/2 gal each | **Active Ingredient:** 18.0% Rosemary Oil, 2.0% Cinnamon Oil, 2.0% Lemongrass Oil
- For tank and tankless misting • Quick control of mosquitoes, gnats, flies & other flying insects
